KEYPOINTS

START IS ON THE WEST SIDE OF LAKE AVE, FACING SOUTH. POINT IS IN LINE WITH THE SOUTH EDGE OF SQUARE TREE PLANTER IN THE SIDEWALK CUT OUT AND THE NORTH EDGE OF THE SEWER MANHOLE COVER IN SAME SIDEWALK, AND IN LINE WITH BLACK UNNUMBERED LIGHTPOLE ON EAST SIDE OF THE STREET. POINT IS ALSO 21.5 NORTH OF GREEN UTILITY BOX 300 120/208V 2209.7, WHICH IS AT THE SOUTHEAST CORNER OF FIRE STATION 1.

FINISH IS ON THE WEST SIDE OF LAKE AVE, FACING NORTH. POINT IS ON THE SOUTH SIDE OF WHITE PAINTED LINE FOR SOUTH PAINTED CROSSWALK AT THE INTERSECTION OF MAIN ST AND LAKE AVE. POINT IS ALSO 7.5' NORTH OF NORTH SIDE OF STORM GRATE ON WEST SIDE OF ROAD, SOUTH OF SAME INTERSECTION.

1 MILE IS ON THE WEST SIDE OF JOHNSON AVE, FACING SOUTH. POINT IS 5' NORTH OF (BEFORE) SIDEWALK TO RED FRONT DOOR TO SIMMONS CENTER, WHICH IS AT THE CORNER OF CHARLES ST AND JOHNSON AVE.

2 MILE IS ON LAKE HOLLINGSWORTH WALKING/RUNNING PATH, FACING SOUTH. POINT IS 27.5' NORTH OF (BEFORE) LINE WITH LP 1000093 (ON OPPOSITE SIDE OF THE ROAD), WHICH IS IN FRONT OF 975 LAKE HOLLINGSWORTH DR. POINT IS BETWEEN MINNEHAHA TR AND BEACON RD.

3 MILE IS ON THE THREE PARKS PATH THAT RUNS ALONG BUCKINGHAM AVE, FACING SOUTH. POINT IS 132 SOUTH OF (AFTER) LP 100133, WHICH IS AT THE INTERSECTION OF SAGAMORE ST AND BUCKINGHAM AVE.

5K IS ON THE THREE PARKS PATH THAT RUNS ALONG BUCKINGHAM AVE, FACING SOUTH. POINT IS 45.7' SOUTH OF (AFTER) GREEN PAINTED MAINTENANCE DRIVE THAT CROSSES THE PATH AT THE INTERSECTION OF CHATFIELD ST AND BUCKINGHAM AVE.

4 MILE IS ON THE NORTH SIDE OF WESTOVER ST, FACING EAST. POINT IS 156' EAST OF (AFTER) GREEN UTILITY BOX E407, WHICH IS ON THE WEST SIDE OF THE DRIVEWAY ENTRANCE TO THE Y. POINT IS ALSO 72' EAST OF (AFTER) THE Y ENTRANCE DRIVEWAY.

5 MILE IS ON NEW JERSEY RD, FACING NORTH. POINT IS 14" SOUTH OF (BEFORE) LINE WITH MAILBOXES IN FRONT OF THE RENTAL OFFICE FOR LAKESIDE APARTMENTS. POINT IS ALSO 39" SOUTH OF (BEFORE) GREEN AND WHITE APARTMENT NUMBER LOCATOR SIGN.

6 MILE IS ON THE THREE PARKS PATH, NEAR THE GOLF T FOR THE 6TH HOLE OF THE A COURSE, FACING EAST, POINT IS 673' WEST OF (AFTER) THE ENTRANCE ONTO THE PATH AFTER LEAVING GLENDALE ST.

10K IS ON THE THREE PARKS PATH, NEAR THE GOLF T FOR THE 8TH HOLE OF THE A COURSE, FACING EAST. POINT IS 476 EAST OF (BEFORE) A SQUARE, WHITE CEMENT POST ON NORTH SIDE OF THE PATH BETWEEN THE BACKYARDS OF A BROWN SHINGLE HOUSE AND A WHITE BRICK HOUSE.

7 MILE IS ON LAKE HOLLINGSWORTH WALKING/RUNNING PATH, FACING WEST. POINT IS 42 WEST OF (AFTER) DRIVEWAY APRON FOR EXIT OF LAKE HOLLINGSWORTH PARK AND BOAT RAMP.

8 MILE IS ON THE LAKE HOLLINGSWORTH WALKING RUNNING PATH, FACING EAST. POINT IS IN LINE WITH THE NUMBER 7 ON THE CAR PORT OF 7 LAKE HOLLINGSWORTH DR. NAIL IS IN THE ASPHALT IN THE BIKE LANE OF THE ROAD.

9 MILE IS ON THE NORTH SIDE OF WALNUT ST, FACING EAST. POINT IS 11"EAST OF (AFTER) EP305257, WHICH IS ACROSS THE STREET FROM THE CHAPEL ENTRANCE TO FIRST UNITED METHODIST CHURCH. POINT IS ALSO 14"EAST OF (AFTER) EAST EDGE OF DRIVEWAY TO SMALL PARKING LOT ON NORTH SIDE OF STREET, ACROSS FROM THE CHURCH.
